MEMBERSHIP CONDITIONS

1.0 **Membership**

1.1 **Eligibility** – The membership shall consist of such individuals as are admitted as members by the Board of Directors. All persons who will be involved with EMP or its productions must be a member.

- a) **Full Member** is person 16 years of age and older with full voting privileges. Annual dues shall be set at each AGM for the following year.
- b) **Youth Member** is a person 15 years and under with no voting privileges. Annual dues shall be 50% of those set for Full Member.
- c) **Associate Member** is a non-performing person of the production or EMP administration with no voting privileges. Annual dues shall be 25% of those set for Full Member.

All members must abide by the Constitution and By-Laws of EMP.

1.2 **Application Procedure** – All prospective members must submit a completed “Application for Membership” form and appropriate fees, which must be reviewed by the Membership Committee who will accept or reject them at their discretion. If rejected, the fees will be refunded.

1.3 **Membership Fees** – The annual dues will be approved at each Annual General Meeting.

1.4 **Membership Period** – The membership period will begin immediately following the adjournment of the AGM and continue until the adjournment of the next AGM.

1.5 **Auditions** – Auditions shall be at the time or times set by the Auditioning Committee. The Auditioning Committee shall decide who shall be invited to participate in any given production. All cast must be existing members of EMP or become a member upon acceptance of a role.

1.6 **General** – The Board of Directors reserves the right to terminate any membership at any time. All cast members are expected to contribute to the production in other areas of activity such as set construction, costumes, publicity, ticket sales, etc. Appearance in any scene will be determined by the Auditioning Committee.
